

MAPs DBT FAQ

Q.1 What is Maharashtra Apprenticeship Promotion Scheme?

A.1 In order to increasing the recruitment of apprentices under the Apprenticeship Training Scheme in private establishments, state government has taken an initiative to supplement the Apprenticeship Training Scheme, department has launched the “**महाराष्ट्र शिकाऊ उमेदवारी प्रशिक्षण योजना**”. This scheme was launched on 3rd June 2021.

Q.2 What all benefits you will get under MAPs scheme?

A.2 Under Maharashtra Apprenticeship Promotion Scheme 75 per cent of the prescribed stipend payable to the apprentices or maximum of Rs.5,000/-(including benefit of Naps Scheme of Rs.1500) per month, which will be less as per the prescribed stipend given to the apprentices by State Government.

Q.3 Who all can register on Portal?

A.3 Students fulfilling the following conditions i.e.

- Apprentices should be domicile of Maharashtra
- He/ She must have undergone apprenticeship training or joined or completed their apprenticeship on or after 3rd June 2021 are eligible to register on this portal

Q.4 What all are required documents for Registration?

- A.4 1) Contract Registration Form,
2) Domicile Certificate
3) Stipend Proof
4) National Apprentice certificate.

Q.5 In how much period apprentices can apply for claim?

A.5 Apprentice can submit the claim within 1 year from the end date of apprenticeship.

Q.6 What all details need to be filled by apprentices on portal?

A.6 Apprentice should fill the required information like Month of the claim, Proof of Stipend paid by establishment in rupees, Benefit under NAPS in Rupees, Benefit under MAPS in rupees, Aadhaar enabled Bank Account Number, Type of account, Name of Bank, Name of Branch, IFSC Code.

Q.7 What is the procedure for payment of reimbursement claims (stipend) to the apprentices?

A.7 The procedure for payment of reimbursement claims (stipend) to the apprentices is as follows

- Once the profile details are submitted by apprentice, the apprentice shall click on claim button
- Claim will be scrutinized at 2 level viz Establishment, Regional Office.
- Claim submitted by apprentice will be visible in login of concerned Establishment and BTRIC
- If claim is scrutinized at various level, and at any level if it found wrong, it will be rejected, send back for rectification and visible in login of concerned apprentice.
- If claim is scrutinized at various level, and at if it found corrected, it will be forwarded to concerned Desk visible in login of concerned apprentice.
- If claim is scrutinized by HO and found correct, it will be forwarded to Accounts Section.

- Account section will prepare bill for scrutinized correct claims and submit it to 'Pay & Accounts Officer'.
- After passing bill by 'Pay & Accounts Officer', amount of bill will be credited in account of DVET/SAA/Admin.
- This amount of bill credited in account of DVET/SAA/Admin will be credited in pool account of MAHA-DBT.
- MAHA-DBT will disburse the amount in bank account of concerned apprentice through 'Direct Benefit Transfer' (DBT) Method.

Q.8 Does Establishment need to register on portal?

A.8 No, Establishment does not need to register on portal, they just need to login with their respective IDs.
